**RULES, REGULATIONS AND CONDITIONS FOR ISSUANCE OF WORK-
MEN'S PASSES AND BADGES BY THE LEWIS & CLARK
CENTENNIAL EXPOSITION**

Every Division, Department, State or Foreign Commission, Exhibitor, Concessionaire or other interest requiring the services of workmen upon the grounds or in the buildings of the Exposition will be entitled to passes for such workmen each day their services are so required and used.

Every pass desired must be requisitioned by the interest desiring the same, on application form furnished by the Department of Admissions, signed by the interest or its accredited agent and approved by the Division or Department of the Exposition from which said interest derives its authority to construct, install or operate. To illustrate: If construction of building or booth, etc., this application must be approved by the Director of Works. If an Exhibitor, the Director of Exhibits must approve. If a Concession, present this application to the Chief of Concessions before applying for passes and badges.

Every pass must be accompanied by a Lewis and Clark Centennial Exposition Badge when presented for admission and the number of the badge must correspond with the number written in ink in the upper left corner on the face of the pass. This badge must be procured from the Department of Admissions at the time of applying for passes.

Every pass and badge fraudulently obtained or misused will be charged to the party obtaining the same at the regular rate of admission, for passes, and one dollar each for badges, and the same will be taken up and cancelled without rebate or recourse.

A deposit of one dollar must be made for each badge issued, which amount will be refunded to the party making said deposit whenever said badge is returned to the Department of Admissions; provided always that there has been no misuse or abuse of said badge or pass.

Every pass issued shall be used subject to the conditions printed or written thereon, and the Lewis and Clark Centennial Exposition reserves the right to change these conditions, rules and regulations at any time it may deem it necessary or expedient.

NOTE: The term (workmen) in its application to passes and badges applies to both sexes.
