### SENIOR CITIZEN'S PROPERTY TAX EXEMPTION

Taxpayers who become 65 years of age on or before March 1, 1967 may be eligible for a partial property tax exemption. The older you are the larger the exemption. There are certain basic requirements that must be met.

- Proof of your age, either by birth certificate, baptismal certificate, hospital birth record or other documents acceptable to the Assessor.
- You must be the owner of record of the property, be purchasing under a recorded sales contract, or have a life estate interest in the property.
- 3. The property must be your permanent residence.
- The household income of the applicant and all other members of the household must not have exceeded \$2500.00 during 1966.

This exemption is not automatic, you must go in person to the County Assessors Office, Room 270, Multnomah County Court House, now so that your application can be filed before April 1, 1967. Take with you your proof of birth, last years property tax statement, your earnings record for 1966. If you are buying on contract, take your copy of the contract with you.

REMEMBER - Room 270, Multnomah County Court House.

With emphasis on improved and additional housing, the above community representatives met with the ANIP Staff, on January 5, 1967.

The Albina Neighborhood Improvement Plan was explained in detail by Herman Plummer. The group discussed the Park development, finance availability and citizen participation.

After discussion on the redevelopment of the vacant lots that will be available for new housing, it was the consensus of the group that careful attention and planning be considered on the following: special efforts be given in maintaining the present residential pattern; a determination be given on what impact the additional housing will make on the public schools; and, if possible, under the Urban Renewal Plan, to create scattered play areas.

#### LEGAL AID SERVICE - NEIGHBORHOOD SERVICE CENTER

The Legal Aid Service of the Multnomah Bar Association, since June, 1966, has operated an Albina Branch at 59 N.E. Stanton, to provide "free Legal Services" for all persons in Multnomah County who, because of lack of funds, would otherwise go without professional legal counsel in civil matters.

Two full time attorneys are available from 8:00 A.M. to 5:00 P.M., Monday thru Friday, or any other time by appointment if regular hours are impossible for the prospective client.

All areas of civil law are covered by this branch office, and attorneys are especially eager to consult with clients BEFORE they agree to purchase aluminum siding, Home Fire Alarm Systems, Encyclopedias, automobiles, houses, baby pictures, \$400.00 vacuum cleaners, etc.

One of the major purposes of this branch is to educate the residents of this neighborhood in the different services available from the practicing members of the Bar in this County. It has become apparent that most people think attorneys are more expensive than they are in fact. The Legal Aid Service works with the rest of the Bar to dispel misconceptions and to encourage frequent use of legal services by all persons -- rich or poor. Attorneys from this office are available to speak to interested groups on any subject of interest to the group. If a specialist is required, the resources of the entire Multnomah Bar Association are available, as well.

#### URBAN LEAGUE ON THE JOB TRAINING (OJT)

This program is designed to develop employment situations where the employee will receive progressive On The Job Training. The project will serve residents 18 years or older of the Portland Metropolitan Area who are underskilled or untrained for the current labor market needs. It is one hundred percent financed by the U. S. Department of Labor Bureau of Apprenticeships and Training and works with the State Employment Service, the State Apprenticeship Council, Unions and other agencies working in the field of employment.

The project locates employer-trainers and recruits, screens and refers potential trainees. Continous contact is maintained with both employers and employees to assure appropriate counseling and guidance.

#### FAMILY COUNSELING - NEIGHBORHOOD SERVICE CENTER

If our house is on fire, we call the fire department for immediate help. Most of us don't expect to take care of serious illnesses or injuries ourselves, but call on a doctor for help. In the families' experiences, at school, on the job and in the community, there can be critical emergencies, family dissensions and misunderstandings that require skilled professional counseling help before too much damage has taken place. Without expert help these situations usually get worse. In emergencies of this sort, the services of Family Counseling at the Neighborhood Service Center may make the difference between a family break-up or a family that can work out its differences and remain together as a group of cooperating individuals working for the growth and happiness of all members.

Family Counseling can often be useful in helping families with small problems that have not yet exploded into emergencies. If children are getting into trouble because they and their parents are not able to talk to each other, it is easier and wiser to rebuild the broken communication lines than to wait until a discouraged youngster burns his bridges by dropping out of school or becomes involved in delinquency.

What may seem to be a problem in another area may actually be something that should be referred to Family Counseling. In some instances of financial difficulties, unemployment, etc., the person may need to see what part he plays in repeating his difficulties and how he can find more satisfying ways of planning his affairs.

Family Counseling in the Neighborhood Service Center is open Monday through Friday from 8:30 A.M. to 5:00 P.M. and evenings by special appointment.

### PHONY "INSPECTOR" SUBJECT OF WARNING

The Portland Bureau of Public Works has issued a warning on the bunco artist who has been operating in the Portland area.

This man telephones or calls at homes, often those of elderly women, and represents himself as a city inspector or as a workman on a sewer line. His method of operation is to inform the householder that he is working on a sewer nearby and that he has observed that the prospects sewer is ready to plug up and needs clearing out. He offers to do the job on the spot for a fee that usually runs about \$25.00.


If he sells the idea, he goes through the motions of cleaning the sewer, probably using flour or sugar in place of solvent. He collects his fee and promptly disappears.

Public Works officials say they have received recent calls, all seemingly concerning the same elusive operator. Most of these calls have been from the North Portland area, which seem to have been the favorite target of this phony.

Anyone approached by a man representing himself as a city inspector wanting to charge for a job of sewer cleaning in the home, should immediately report the information to Tom Turnet, Maintenance Division of the Bureau of Public Works, 228-6141, Ext. 412.

The weeds, vines and grass along the alley should be cut. All shrubs, bushes and trees should be trimmed so that the branches will not be extending out into the alley. Also, tree branches on the alley should not be lower than eight (8) feet from the ground.

All trash should be removed from the back yard and garage. These trash piles serve as a breeding spot for rodents and many different types of insects.



### SEASONAL GIMMICKS - A Catch in Every Contract

Like homing pigeons returning to the roost, certain types of swindlers appear again and again.

Their ingenious schemes are carefully designed to pluck cash from homeowners and renters who swallow their bait.

Here is a description of the most frequently used gimmicks, nearly all related to home improvement or beautification:

MODEL HOME DEAL - A salesman offers free installation of aluminum siding if the house can be used as a model in "before and after" advertisements.

Homeowners who fall for this pitch find the papers they have signed in their haste to take advantage of the offer turn out to be iron-clad contracts for a job which will cost hundreds of dollars more than a reputable firm would charge.

<u>RE-ROOFING GYP</u> - An alleged repairman shows the homeowner a handful of shingles which he claims fell from the roof and warns the entire roof may cave in if not fixed immediately.

The homeowner usually winds up paying an exhorbitant price for a shoddy job. Chimney repairmen use loose bricks to make a similar sales pitch.

You are given continued counseling and advice from the beginning of the inspections process until the work is completed. Periodic and final work inspections are made, to insure you that the work is done properly and that you receive the maximum value for each dollar spent.

Your properties may need little or no work to be done, but we must inspect all properties, so be expecting our Staff Advisors and give them your cooperation. For your protection, ask for his identification card.

## SEASONAL GIMMICKS - A Catch in Every Contract

Like homing pigeons returning to the roost, certain types of swindlers appear again and again.

Their ingenious schemes are carefully designed to pluck cash from homeowners and renters who swallow their bait.

Here is a description of the most frequently used gimmicks, nearly all related to home improvement or beautification.

TERMITE TALE - Itinerant "exterminators" find serious termite problems in a home and sell the owner a termite control job.

The exterminators usually return several times in succeeding months and sell additional services after finding more termites.

Such termite inspectors usually bring their own insects along to display if they can't find any on the property.

DRIVEWAY SEALER - Claiming he just finished a job down the street and has some material left, this swindler offers to resurface your driveway at a bargain price.

But instead of using a quality sealer, the swindler will probably use something similar to old crankcase oil which doesn't dry and may damage carpeting if tracked into the home.

FURNACE FARCE - A free furnace inspection by a man who claims to represent some official agency, reveals "serious and dangerous" defects. (These are usually non-existent).

After refusing to reassemble the furnace, which he dismantled during the inspection, the "inspector" tries to sell a new furnace which is often way over priced.

If this proposal is approved and funds are made available, it will be possible to employ and place into supervised recreation over 200 young people between the ages of 12 and 21. The Community Service Workers will act as consultants for the supervisory staff of this summer project.

#### CARE OF TREES ON PARKING STRIP

You can help them to survive and prosper under city conditions by taking a few simple precautions.

<u>WATER</u> - Thoroughly, especially during the first few years of the tree's life. Once a week in hot, dry weather in the spring and July and August. At least four pails full of water should be given at each watering.

CULTIVATE AND MULCH - Keep soil loose so that oxygen and water can get to the roots. If soil is hard-packed, water is useless. A mulch compost, sawdust, leaves or straw will help keep soil from drying out and will prevent packing.

FERTILIZER - Your tree will not have to be fertilized the first year. In the early spring of the second year and each spring thereafter, fertilize with two pounds of 6-10-4 per inch of trunk diameter.

# SEASONAL GIMMICKS - A Catch In Every Contract (Reprint from FACTS - Portland Better Business Bureau)

Like homing pigeons returning to the roost, certain types of swindlers appear again and again.

Their ingenious schemes are carefully designed to pluck cash from homeowners and renters who swallow their bait.

Here is a description of the most frequently used gimmicks nearly all related to home improvements or beautification:

<u>CARPET CAPER</u> - An itinerant salesman claims to have just enough carpeting left from a nearby job to carpet a room. He will sell it at bargain price.

When the homeowner attempts to lay the material, it is usually found to be much smaller than claimed and of a very cheap quality.

Linoleum peddlers use the same gambit.

Properties that are not structually practical or feasible for rehabilitation are acquired and cleared.

This removes from the neighborhood those properties that affect the appearance and value of other properties, thereby eliminating the blighting effects that otherwise would plague the neighborhood.

The properties so cleared will be available to builders, sponsors and other individuals for development of new housing.





#### ROOF AND GUTTER FAKERS THRIVE DURING LATE SUMMER

After the long, dry summer the fall rains are sure to come and in anticipation of this homeowners are likely to be well aware of the importance of checking on the conditic of roofs, downspouts and gutters.

Ready, eager and willing to participate in this pre-fall care are the gutter racketeers and the phony roof repairmer who annually take on almost frenzied activity during late summer and early fall.

This year is no exception. The transient roof sprayers are particularly active with their tanks of "fireproof" --"leak-preventing" sprays. Past experience forewarns that the true nature of this spray can be anybody's guess. Maybe it consists mainly of crank case drainings, or sometimes it has the characteristics of kerosene. But whatever it is it isn't fireproof and it will not prevent bad roofs from leaking.

Avoid dealing with unknown workmen who are likely to disappear into nowhere after the job is done.



This Park Site, selected by the project area residents, contained 32 structures, all were houses except one, a grocery store. This meant that the 25 families and 12 single individuals living there would need to find new homes.

The first family to move from the Park Site found another home in early August, 1965, within a few weeks after the Federal Government approved the Project. The last family to move from the Park Site moved in late November, 1966.

Four households found new homes in the Project. Eight more found homes in the larger Albina area outside the Project; and 25 households moved outside the Albina area. The general trend has been for families to move farther north and east.

The Development Commission paid a total of \$3,276 in moving expenses to these 37 households. The average cost to move a family to their new home was \$102. In addition, the Commission found that 18 families qualified for Relocation Adjustment Payments totalling \$6,330.

The following stories are samples taken from the Commission's Relocation Files, and show the type of improvement made by many families who have moved to new homes:

Pictured below is the N. Commercial Avenue home of a family with twelve children. The Development Commission bought their home in January, 1966, and proceeded to help the family make preparations to move.

This family bought a duplex in the Walnut Park area and reconverted it into a

single living unit. They moved during February, 1966, and are quite pleased with their home and neighborhood. The Commission paid the costs of their move, and found them eligible for a Relocation Adjustment Payment as well.

## JOB CORPS FACTS

Job Corp is a voluntary national residential training program for out-of-school, out-of-work, underprivileged young men and women. Job Corp enrollees must be:

- I. 16 through 21 years old
- 2. Citizens or permanent residents of the U.S.
- 3. School dropouts for three months or more
- 4. Unable to find or hold an adequate job
- 5. Underprivileged from having grown up in impoverished surroundings
- 6. In need of a change of environment in order to become useful and productive citizens

The goal of the Job Corp is to prepare young men and women for jobs in which they can earn a decent living.

Each enrollee receives room and board, medical and dental care, work clothing, a normal allowance to be used toward the purchase of dress clothing, and a monthly living allowance of \$30.00, less deductions for Social Security and taxes. In addition, each enrollee will receive a readjustment allowance of \$50.00 for each month of satisfactory Job Corp service. An enrollee may allot up to \$25.00 per month of his readjustment allowance to a qualified dependent. Each month, Job Corp will match the allotted sum with an equal amount.



## ALLEY CLEAN-UP BY JUNIOR EXECUTIVE BOARD


