VAMPORT HOSPITAL TO BE CLOSED

The Vamport Hospital will have to start curtailing its operations on the 15 of April unless funds are made available to cover the loss incurred in the carrying out of its operations.

This hospital is here to serve the 18,000 residents of Vanport City. No community of 18,000 people should be without hospital facilities regardless of its location.

In the Fortland area it is even more important to us as residents of Vanport that this hospital not be closed as there is a great shortage of hospital space in the City of Fortland. The following are some facts that you should know about the Vanport Hospital.

- l. Helf of the patients at this hospital come from areas outside of Vanport City. In most instances this is because there is no room for them in other hospitals in the Portland area.
- 2. The staff of doctors now using the Vanport City Hospital has been on a steady increase since the first of the year. One reason for this is that those doctors returning from the Armed Forces are unable to get their patients into other hospitals as quickly.
- 3. This hospital is an "overflow" institution. It furnishes excellent hospial facilities to all people in the Portland area who might otherwise not be able to enter any of the very overcrowded hospitals in Portland.
- 4. If a program of building expansion was started immediately to enlarge

the facilities at hospitals in the City of Portland it would take from 18 months to two years before they could be available for use on a per with the facilities now available at the Vancort Hospital.

- 5. Funds for the continuance of the hospital are no longer available through the Federal Works Agency, and some other source must be found to supply the cash to carry out this vital operation.
- 6. The Hospital Superintendent has indicated that his efforts to see that the hospital is allowed to remain open would be greatly helped if residents of Vanport City and Portland were made aware of the situation and wrote letters concerning their desire to see the hospital remain open.
- 7. The Vanport Residents' Emergency Hospital Committee is a working committee of people living in this area to aid you by making available to you the information you need to write a letter. By supporting the activities of this committee you will be aiding in the program to keep a hospital in Vanport City for your use in the case of an emergency.

REGISTRATION BOOTH OPENS
FOR VANPORT VOTERS

The registrar of Multnomah County has just announced that there will be a Registration Booth at the Sheriff's Office from Arpil 3 until the close of the registration period, April 16. The booth will be open from 10 a.m. until 6 p.m. daily. In order to avoid the last minute rush, you should make it your duty to get registered today.

Representatives of three Vanport Community groups met Tuesday night to discuss action on the question of the Vanport Hospital being forced to close unless funds are made available from some source to continue its operation.

Feeling that their bost expression of action would come through closer organization on this one situation the group initiated the Vanport Residents' Emergency Hospital Committee. Officers elected were, Mr. J. Lewis Ackerman, Chairman, and Mrs. Carl Jensen, Treasurer. The immediate job of the group is to present to the resident of Vanport City the facts concerning the possible closing of the hospital and the effect that such action would have on each resident.

Their first step to acquaint more people with the problem is a planned demonstration to take place Saturday morning in Vanport City. Further immediate action required is the writing of letters to the following persons whom it is known can be of help in the plan to keep the hospital here.

In addition to the above it is of vital concern that those of us whose homes are in States other than Oregon, contact our representatives and make them aware that federal funds must be made available for the continuance of the hospital that is here to serve us while we are living in Vanport City.

Everyone has been reading in the local papers about the Smallpox scare in California and in Washington. There have been no cases reported in this area but it is advisable to be vaccinated if you have not been in the last two years. Many people have been vaccinated at the Multnomah County Court House and the Vanport Health Department during the past week.

LIPRARY CARDS

Effective April 1, all cards issued bearing numbers above 8,000 may be used for Vanport circulation only. However, people wishing books from Portland Library may have them delivered to the Vanport Library by requesting same from the Vanport Librarian.

AMERICAN VETERANS' COMMITTEE

At a meeting held on April 2 at Community Building #2 a Chapter of the AVC was formed. Temporary officers were elected to serve for 60 days or until a permanent constitution with permanent officers is adopted. The group will meet the second and fourth Wednesdays of every month at Community Building #2 to discuss questions of community interest. The first order of business will be a discussion of ways and means of keeping the Vanport Hospital in operation. All veterans, men and women, are invited to attend the meetings.

CONGRESSIONAL COMMITTEE STUDIES VANPORT SCHOOL APPROPRIATION

The future of the Vanport Schools now lies in the hands of a congressional committee which is considering a bill to appropriate funds for all such projects in which the emergency need continued after the Lanham Act funds were terminated.

The outlook for the eventual passage of the bill is favorable but rapid passage is extremely necessary if we are to be in a position to renew contracts with our teachers before they accept other offers.

To insure prompt action on this bill (H.R. 5796) letters and wires indicating the urgent need should be sent to the following Senators and Representatives: Representative Lanham, Chairman of the House Committee on Public Buildings and Grounds (now handling the bill); Representative Homer Angell from Oregon; and Senators Wayne Morse and Guy Cordon of Oregon.
