PREFACE

A successful Urban Renewal Neighborhood Improvement Project indicates a favorable and unique partnership program, representing the voluntary participation and interest on the part of the residents and other interested citizens and the technical aid and guidance on the part of public official agencies.

In the Albina Neighborhood Improvement Project much of the citizen participation is exercised through a neighborhood committee, known as the Albina Neighborhood Improvement Committee.

The Albina Neighborhood Improvement Committee is composed of all block leaders and other interested residents and non-residents. Its function is to discuss, determine and correlate all aspects or conditions affecting the Albina Neighborhood Improvement Project, whether initiated by the Executive Board, Block Leaders, Sub-Committees, Residents, or Staff. From this group nine members are elected, to constitute the Executive Board, two of whom serve as Co-Chairmen. The function of the Executive Board is to be the immediate liaison between the Committee, the Project Staff and the Portland Development Commission, which is the Local Public Agency for the City of Portland. Through the use of Neighborhood Sub-Committees, items of interest are studied and researched; and, through the Executive Board, are presented to the Neighborhood Committee for determination and action.

Some of the more visible accomplishments, to date, are: sidewalks and curb repair; removal of large trees from parking strips; paving of all alleys; removal, by the utility companies, of some 220 poles, replaced by three poles per block; and 300,000 feet of wiring, replaced by single triplex lines; improved street lighting; improved services, such as street cleaning, alley cleaning and police patrol. All but two of the thirty-four properties, where the New Park will be located, have been acquired.

This booklet is a compilation of the monthly bulletins published in 1965, showing the work of the Portland Development Commission and the Albina Neighborhood Improvement Committee in the Project Area.

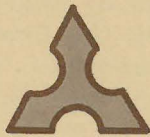

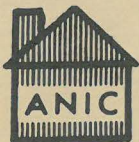

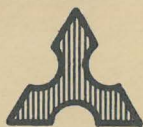
FEBRUARY GENERAL MEETING OF THE NEIGHBORHOOD IMPROVEMENT COMMITTEE

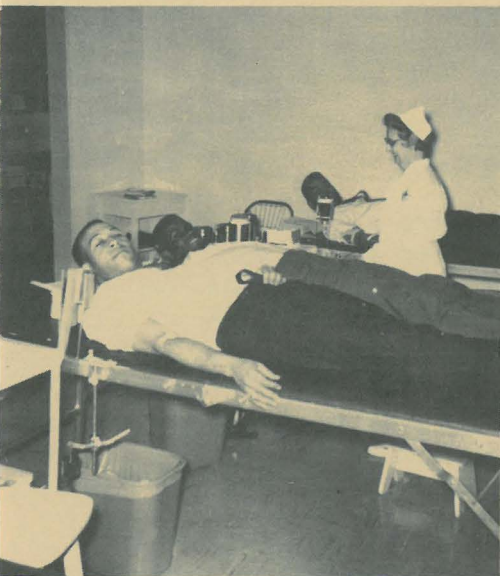

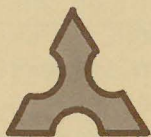

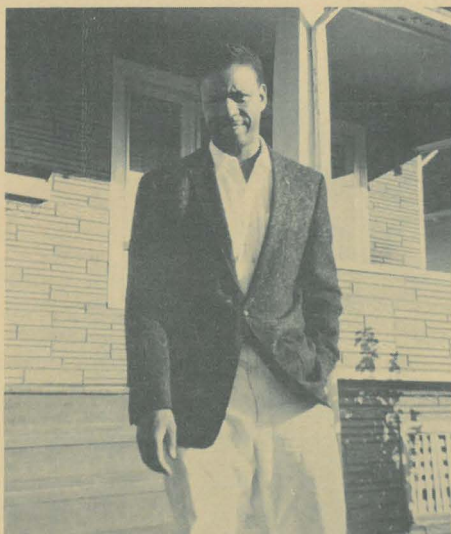
STREET SWEEPING SCHEDULE FOR THE PROJECT AREA

A year ago in ANIIC-DOPE it was announced that signs would be placed on streets one day prior to the actual sweeping. In checking with Mr. Frank Woodruff, City Street Sweeping Supervisor, it was learned that the sign placing plan had to be abandoned. The idea was tried twice on a trial basis and it was found to take too much time just for placing the signs, and that owners would not remove their cars even though the signs requested removal.

The regular city street sweeping schedule is still being followed in the Project area. This calls for macadam streets to be swept every 6 weeks and paved streets every 14 working days.

CITY COUNCIL APPROVES UTILITY COMPANIES' PLAN FOR IMPROVED SERVICES IN PROJECT AREA

The Portland City Council acted on a Portland Development Commission resolution, through an ordinance on March 11, 1965, requesting approval of Portland General Electric Company and Pacific Power and Light Company's plan for improved electrical service in the Improvement Project Area.

The over-all plan calls for the elimination of duplicated facilities, removal of some poles, cross-arms, and wires no longer needed. Street lights will be installed in the middle of blocks where lights are not now provided.

With this approval by the City Council, the utility companies will begin their work immediately on this phase of the project.

LARRY COONS LEAVING

On April 1, 1965, Larry Coons, Portland Development Commission Assistant Director, will assume his new duties as director of Salem's Urban Renewal work. He wishes to thank all the people who have worked so closely with him during the past years. Larry feels that the experience of working with the residents in Albina was very valuable and that it will help him in his future work in Salem.

NEIGHBORHOOD YOUTH CORPS PERSONNEL AT WORK

On Saturday, March 20, 1965, five boys from the Jefferson High School Neighborhood Youth Corps group worked cleaning up the yard of someone in need.

This project was done with the cooperation of George Glanz & Son Disposal Service, the Portland Bureau of Health (Mr. Robert E. Chapman, Sanitary Inspector), Multnomah County Public Welfare (Mr. Robert Emery, Caseworker), and the Neighborhood Youth Corps staff and personnel. We want to thank all those who were involved for their aid in making Portland a better place in which to live.

ECONOMIC OPPORTUNITY ACT NEWS

On Friday, March 19, 1965, Mrs. Isaac Payne, 3946 N. Borthwick Avenue (Co-leader for Block 20) was selected as a member of the permanent Albina Citizens' War on Poverty Committee. This group will continue the work started by the temporary Committee several months ago.

PROJECT AREA ACTIVITIES COMING UP

In the month of April two different groups of college student volunteers will be in the area to work with Information Center staff and Block Leaders to take a census survey of the Improvement Project Area and to enlist blood donors for the ANIP Blood Bank.

On April 8 and 9 a group of students from Washington State University will be here; on April 17 there will be a contingent from Idaho Schools, principally from Idaho State University.

We ask for the cooperation of area residents in welcoming these visitors and in assisting in the planned surveys.

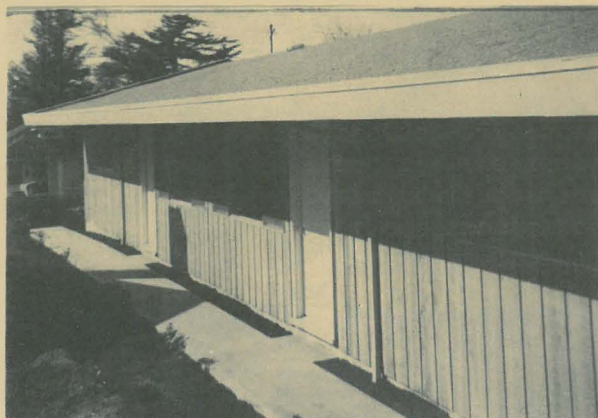

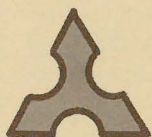
YARD IMPROVEMENTS MADE

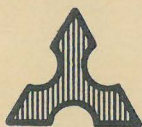


STUDENTS VISIT IMPROVEMENT PROJECT

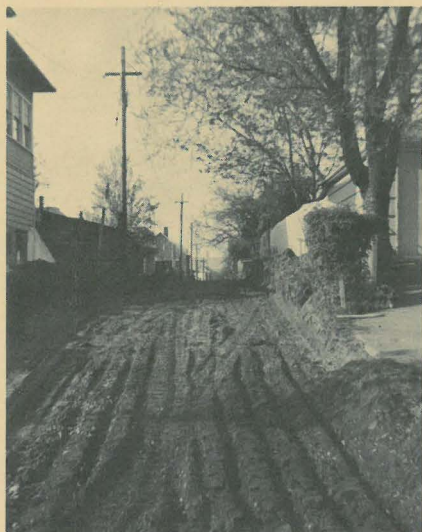

In the news this month is the newly painted home at 3834 N. Commercial Avenue. We commend the owner, Pleas Taylor, on this greatly improved structure.

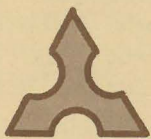
NEW REHABILITATION ADVISOR NAMED FOR ANIP

VANDALISM TO TREES REDUCED

The Tree Program Subcommittee reports that vandalism in relation to our new tree planting program has been reduced considerably. It commends those parents who, by counseling with the children, have helped to bring about this reduction.

The Subcommittee is now determining a more workable program to be instituted by the time of the planting season, which is usually from the fall of the year to the spring.

REPORT ON STRUCTURE INSPECTIONS

Re-inspections of houses in the area are moving along at a satisfactory pace. Approximately 40% of the structures have been inspected.

The two City of Portland Building Inspectors, Mr. Jack Chegwidan and Mr. Everett Powell, report that the response from those contacted for re-inspection has been very good.

These inspections are to the advantage of the home owner and everyone is expected to cooperate when the inspectors come calling.

We have word from the contractor that, with continued good weather, the black topping of the alleys will move along rapidly.

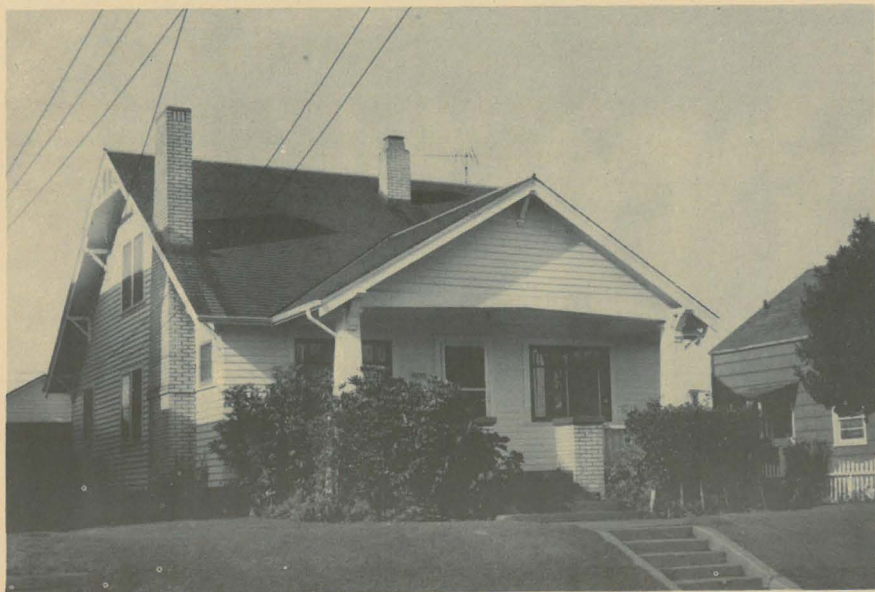

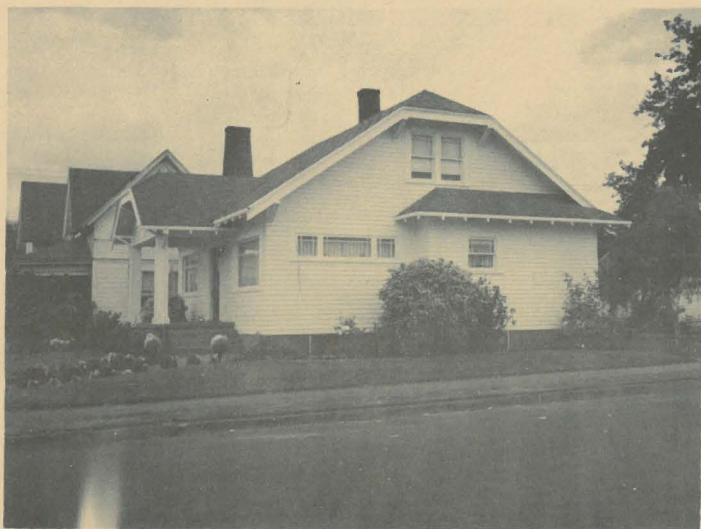

Purchaser's property will be used for model or demonstration purposes

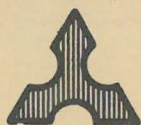
Seller's product or service will increase the value of purchaser's property

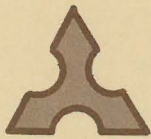
NEW REHABILITATION ADVISOR

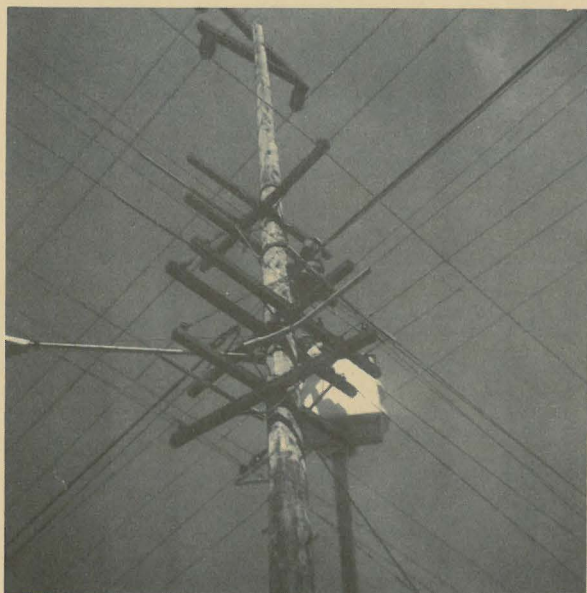
Over 45 per cent of the property in the area has been inspected by the City building inspectors. Fifty-five per cent of the properties inspected have been visited by our rehabilitation advisors. At this printing, 44 of the residents are now in the process of improving their structures.

It is suggested that all property owners contact the project center and take advantage of the expert advice in planning and financing for their home improvements.

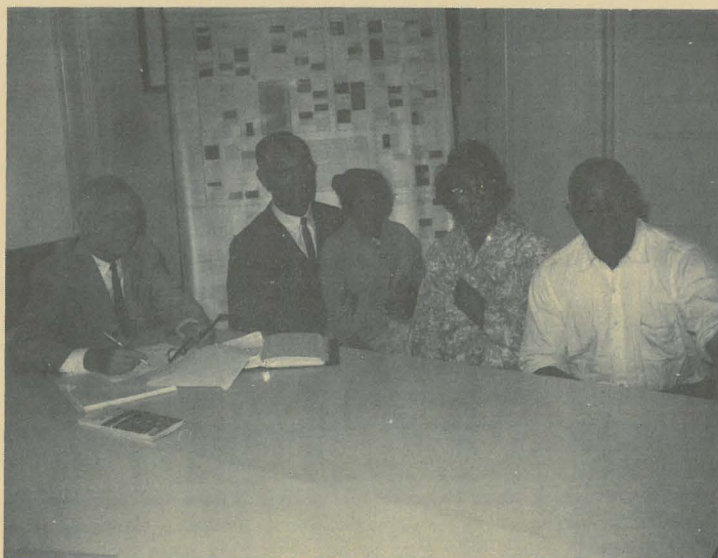


BOY SCOUT EXECUTIVE VISITS CENTER

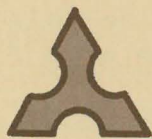

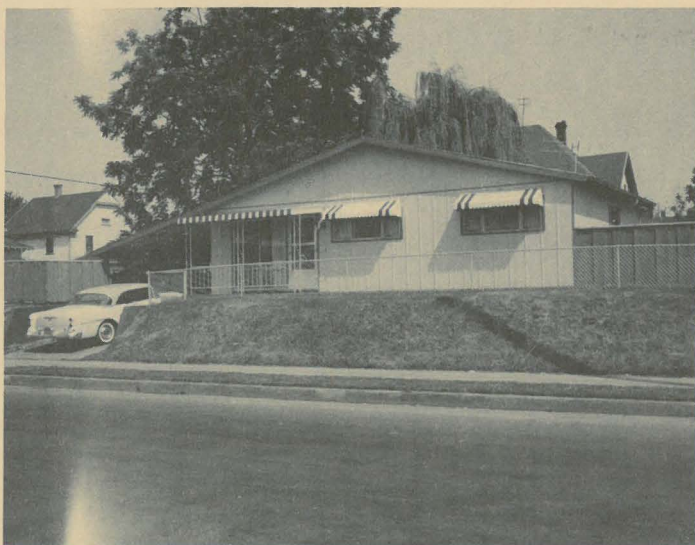
PARK SITE ACQUISITION REPORT

Along with our accelerated program in home improvements, you will be confronted by numerous "high pressure" salesmen representing various contractors. These individuals are out to make the "fast buck". They will use such stock statements as -- "we can do it real cheap for you as we have a crew standing by in the area"; "we will use your property for a model, and save you money". "I am the contractor assigned to this area".

We suggest that you contact the Albina Neighborhood Improvement Information Center for professional service and advice before signing any papers. Usually, once you sign, you are obligated to fulfill the terms of the contract.

We suggest that if you plan to make some improvements or additions to your home, please call the Center and one of the Rehab Advisors will be glad to help you. His services are free as he is employed for the purpose of giving you this technical and professional service.

Some of the things he will do for you are:

1. Draw designs for work desired.
2. Write specifications for work to be performed.
3. Secure three or more competitive bids from reliable, established and certified contractors for work to be performed.
4. Aid you in securing financing if desired.
5. Supervise the job from start to finish.

May we remind you again that all of these services are free to you and do not commit yourself to a contract by signing unless you have contacted our office. No reliable contractor will refuse to work through your Rehab Advisors.

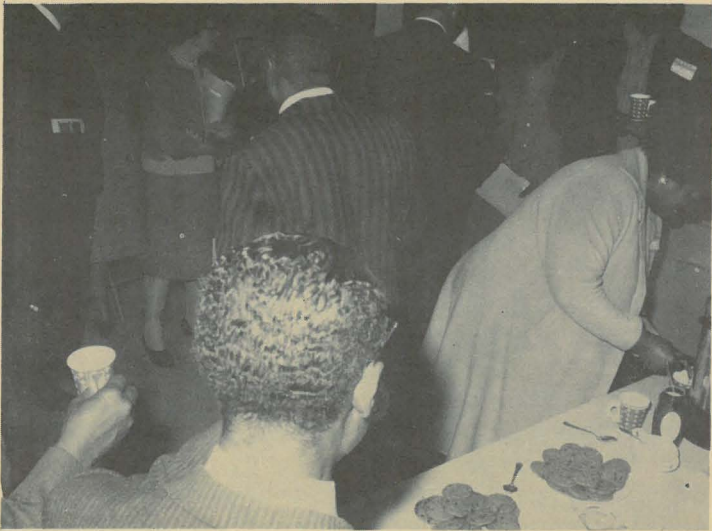

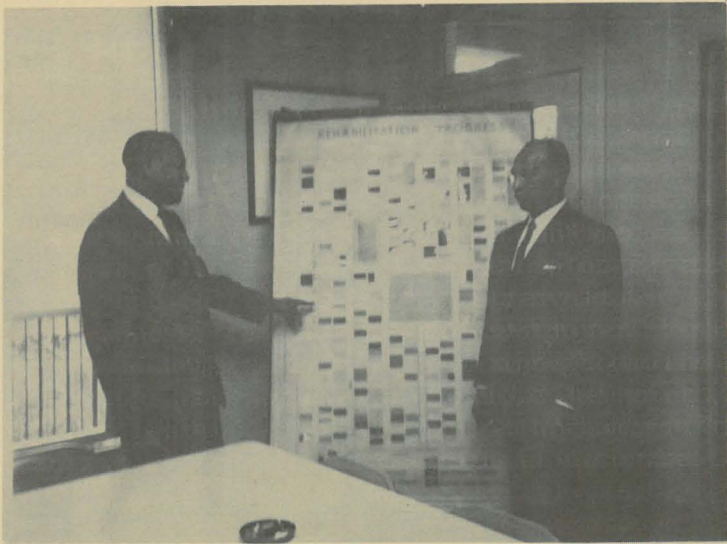
